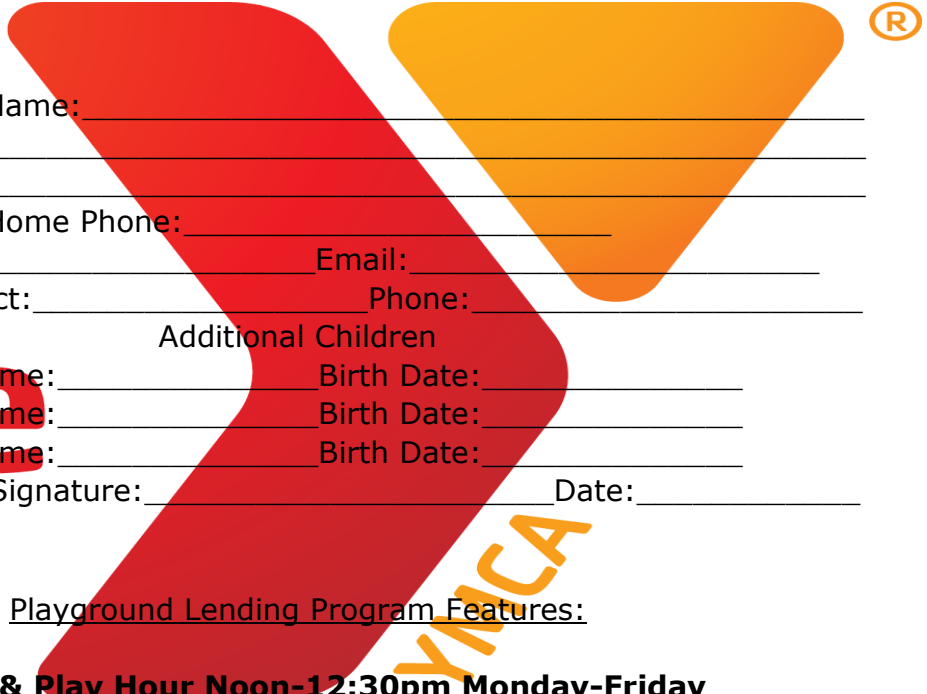

Policy

There is **NO FEE** for this program. Children 10 and up may register for “The Play Program”. Ages 11 and under are not permitted in the building unless there is a youth program offered. Children can use and play with designated equipment during *scheduled* days and hours indoors or, weather permitting, borrow outdoor equipment to use outdoors in the park during general hours of operation. Children **MUST** have turned in a completed and signed registration form before using this program along with any other waivers necessary. **Parent/Guardian MUST be present upon registration.** Children will be issued a **PLAY CARD** which must be turned in each time in exchange for using equipment. Children will sign-in daily per each visit as we will be keeping track of program and facility usage. If child misuses equipment or violates any rules and/or regulations they will be suspended from using this program for 2 weeks. Any misconduct thereafter will be handled accordingly. If child loses **PLAY CARD** there is a FEE of \$1 for a new replacement card.

If child decides to participate in any other youth programs that become available, a FEE at the member and non-member rates will be applied at the time of registrations. There is **NO FEE** for the Playground Lending Program.

This program is supervised **INDOORS ONLY** and Outdoors for the Lunch & Play Hour by the regular Staff/Volunteers on duty each shift. There will not be a special assigned Youth Staff Member supervising the children during the program hours otherwise. The YMCA Staff is not liable and responsible for children outside of the YMCA Youngsville Branch Building.
